## **FINAL REPORT**

### **1. SUMMARY**

The Napa Valley Transportation Authority, (NVTA) has developed a 2.8% overall Disadvantaged Business Enterprise (DBE) race neutral goal applicable to Federal Fiscal Year (FFY) 2023, 2024, and 2025 contracting opportunities assisted by the Federal Transit Administration (FTA) in accordance with revisions to 49 CFR Part 26 (Participation by Disadvantaged Business Enterprises in US Department of Transportation (DOT) Programs) published in the Federal Register on October 2, 2014.

The goal is applicable to an estimated total of FTA dollars that are budgeted for three (3) active contracts with federal funding between October 1, 2022, through September 30, 2025.

In the event of changed circumstances, NVTA will re-evaluate to determine whether the established goal continues to be realistic or if a mid-period adjustment is warranted.

The DBE goal developed is based on the projected availability of ready, willing, and able DBEs in relationship to all comparable businesses which are known to be available to compete in NVTA's FTA-assisted contracts. The overall goal reflects NVTA's determination of the level of DBE participation which would be expected absent the effects of discrimination.

### **2. FTA ASSISTED CONTRACTS**

A total of \$33,322,800 in federal dollars is budgeted for three (3) active contracts awarded during FFY 2022 with their contract duration continuing through FFY 2023 to 2025. The three (3) partially federally funded contracts are for 1) NVTA's Vine Transit Operations, 2) Vine Bus Maintenance Facility (new) and 3) Imola Park and Ride.

## ***Vine Transit Operations***

Public transit service began in the City of Napa in the 1970's as the Vine Intercity Neighborhood Express (V.I.N.E). The County of Napa assumed control of the V.I.N.E a few years later. In 1998, NVTA took over the operations of services from the County. NVTA dispensed with the acronym and the transit system is now just referred to as Vine Transit. Since inception, purchased transportation was provided through a third party contractor for fixed transit. Paratransit services were managed through a separate contract, but with the same purchased transportation provider up until 2009.

Since 2009, NVTA has had a purchase transportation contract with a single provider for both fixed route and paratransit services. The most recent purchase transportation contract was approved by the NVTA Board of Director's for a seven year agreement (five year base plus two- one year options) beginning in January 2022 and ending in December 2027 with options years extending the contract to December 2029.

## ***Vine Bus Maintenance Facility***

In July 2021 NVTA released the bid for its long anticipated construction of its new Vine Bus Maintenance Facility. The contract was awarded on November 23<sup>rd</sup>, 2021 and construction began in January 2022. The Vine Bus Maintenance Facility is anticipated to be in-service by the winter of 2023. A Transportation Infrastructure Finance and Innovation Act loan in the amount of \$19,917,401 was awarded to NVTA to complete the funding package.

When completed, the 8.3 acre property will feature a 20,000 sq. ft. maintenance building with six service bays, an 8,000 sq. ft. administration building and regional meeting center, modern bus wash, secured parking for up to 100 transit vehicles, and parking area for employees and visitors. Total project costs is approximately \$41 million which includes property acquisition.

## ***Imola Park and Ride***

Construction began on the Imola Park and Ride in early January. Among other enhancements, the project includes infrastructure upgrades and installing lighting on the southbound and northbound ramps. Pedestrian friendly sidewalks, bicycle storage and bike lanes connecting both ramps were also constructed under Highway 29 on the south side of Imola Avenue.

The improvements will allow riders to get to the corridor and the Route 29 bus via walking, cycling, transit, and driving to the fully upgraded park and ride adjacent to the highway. The project will include stop facilities, sidewalks and waiting area with lighting, wayfinding, shelter, seating, Wi-Fi, and additional bike storage. Next to the park-and-ride lot is a new bus stop on the on-ramp to Highway 29 where express buses going to the El Cerrito del Norte BART station and Vallejo ferry terminal will begin service in October 2022.

Substantial completion of the project occurred in October 2022. Future upgrades include signage directing vehicles to the park and ride and installation of additional electric vehicle charging stations.

The three (3) active service type contracts and their budget allocation to be supported with FTA funds are in *Table 1* below.

A two-step process is used to determine the overall goal for these contracts.

### 3. OVERALL DBE GOAL METHODOLOGY

The goal setting methodology consists of the following four (4) procedures and follows FTA's 2-step process:

- A - Determine the weight of each type of work by NAICS (North American Industry Classification System) code for programs receiving FTA funding to occur between FFY 2023 - FFY 2025

B - Define NVTA's market area and determine the availability of DBE firms within the market area

C - Calculation of NVTA's Base Figure Goal (Step One)

D - Adjust the Base Figure based on DBE attainment in the past three (3) years (Step Two)

**A - Determine the weight of each type of work by NAICS code for FTA assisted programs**

The following FTA-assisted programs are included in NVTA's capital and operating budget for FFY 2023 through FFY 2025 covered by this goal. FTA-assisted contracting for FFY 2023 through FFY 2025 is expected to consist of three (3) programs, exclusive of contracts for the purchase of transit vehicles, which are not subject to this goal-setting process. Additional projects may be undertaken if additional funds become available; the overall DBE goal will then be adjusted if necessary. The projects are listed below with prime and sub-contract opportunities listed, and showing their weighted values by NAICS code in *Table 2 shown* below.

1. *Vine Transit Operations*. Contracted services to operate NVTA's fixed route, commuter, and demand response services. This is a single contract to operate and maintain the fleet for all transit services provided and to maintain the operating and maintenance facility.
2. *Vine Bus Maintenance Facility*. This is a single award contract to construct the new Vine bus maintenance facility that will house transit operations, administrative offices, training, emergency facilities, transit fleet, and maintenance of all transit vehicles.
3. *Imola Park and Ride*. This is a single award contract to restore and reinstate a park and ride facility. This project will be utilized by NVTA's Vine commuter express bus routes which is conveniently located in either direction of the State Route 29 on and off ramp.

NVTA had initially considered subcontracting opportunities for the Vine Transit Operations Operator prime contract, however based on past experience; the prime contractor performed all functions of the operation with in-house staff. The only possible services to be contracted out are very minor contracts for uniforms and towing services. These contracts have no material impact to the overall contract and were not considered to be broken out for DBE availability.

***B - Define NVTA's market area and determine availability of DBE firms within the market area***

Define Market Area. NVTA serves as the countywide transportation planning body, public transit and paratransit services provider within the incorporated and unincorporated County of Napa. Its operation is located in Napa County with its services extending into the counties of Solano, Contra Costa, and Sonoma.

NVTA's traditional market area is comprised of eleven (11) counties: Alameda, Contra Costa, Marin, Napa, Sacramento, San Francisco, San Mateo, Santa Clara, Solano, Sonoma, and Yolo County.

The following areas were considered in determining NVTA's local market area:

- 1) The area in which the substantial majority of the contractors and subcontractors with which NVTA does business are located;
- 2) The area in which NVTA spends the substantial majority of its contracting dollars; and
- 3) The area in which NVTA provides its services.

For the contracted transit services transit, there are limited number of companies who provide full-service transit operations services. NVTA relied on past experience and known bidders for this type of contract to determine the availability of firms.

Determine Availability of DBE Firms. NVTA determined the availability of DBE firms that are willing and readily available by

- 1) Using the California's Unified Certification Program (CUCP) directory identifying the number of registered DBE's willing to perform work in NVTA's market area, as defined above, for each of the anticipated contracts, based on the NAICS codes most relevant to each contract; and
- 2) The Countywide Business Patterns (CBP) data from the US Census Bureau to identify the total number of business available in NVTA's market area for work on each contract, based on the same NAICS codes. Data used for the CBP was released by the US Census Bureau in March 2020.

The proportion of DBE firms to all available firms within the NVTA market area is shown in Table 3 below.

### **C - Step One – Determine Base Figure (49 CFR 26.45 (c))**

Step One of the goal setting process is to determine the base figure for the relative availability of DBEs based on the evidence of ready, willing and able DBEs in relationship to all comparable businesses known to be available to compete for FTA-assisted contracts NVTA awarded and anticipates to award during the goal period.

A base figure was calculated by multiplying the weighted percentage of funds to be expended for each NAICS Code by the relative availability of DBE firms as shown in *Table 4* below.

The Base Figure for all NAICS Codes was totaled, resulting in a **4.9% Overall Base Figure**.

## **D - Step Two – Adjust Base Figure (49 CFR 26.45 (d))**

Step Two makes adjustments to the Base Figure formulated in Step One.

Per CFR guidelines, following calculation of a base figure, all available evidence must be examined to determine what adjustment, if any, is needed to modify the base figure to arrive at an overall goal. To determine an adjusted base figure, NVTA has reviewed information related to the proven capacity of DBE firms to perform similar contracts.

### Past DBE Participation

For adjustments to the Base Figure, NVTA considered the past DBE participation to be an accurate measure of the expected current capacity of DBE firms to perform work on its federally assisted contracting projects.

NVTA determined that the contracts for FFY 2023-2025 are similar to the previous service contracts issued in the last DBE Goal cycle, specifically the contracted transit services project is a renewal of operating assistance (transit service operations). With the exception of the two (2) construction type contracts as there were no previous construction contracts to be compared during that time frame.

In regards to past DBE performance, NVTA's FFY 2020-2022 Overall DBE Goal for federally funded projects was set at 2.8% which was never attained during that triennial cycle. Unfortunately, during this time period NVTA had to drastically cut back on its Vine Transit Operations services and delay the two (2) construction projects due in part of the national pandemic (COVID-19) and the restrictions placed by state, region and local governments on the public. NVTA's DBE attainment during the past three (3) federal fiscal years, based on semi-uniform reports submitted to FTA, is shown in *Table 5* below. Based on this information, an adjustment that takes into account the level of DBE attainment over the past three (3) years (using the median of the three (3) years, eliminating extremes – whether high or low) is deemed appropriate and is described below in *Table 5*.

The median of the percentages of past DBE Attainment is calculated by taking the middle of the three (3) percentages, resulting in a median of 0.5% this adjustment is obtained by averaging the **Step One** - Weighted Base Figure of 4.9% with the Median of Past DBE Attainment of 0.3%.

- Base Figure = 4.9%
- Historical Median of Past Participation = 0.3%
- Adjustment: (Base Figure 4.9%) + (Median of Past Participation 0.3%) divided by 2
- The Base Figure is then rounded to 2.6%

**Conclusion**

The **overall DBE goal** for FTA-assisted contracts FFY 2023 through FFY 2025 is **2.6%** with DBE participation sought on a race/gender neutral basis.

**4. DISPARITY STUDY**

NVTA considered the evidence presented in recent disparity studies that were conducted by the Bay Area Rapid Transit (2017), California Department of Transportation (2016) and SFMTA (2016), and determined that these findings do not match the nature and scale of the contracts issued during the FFY 2023 - FFY 2025 DBE cycle. Should new contracting opportunities occur that would require revisions to NVTA's Goal, disparity studies would again be considered as a source of information that may warrant further adjustments to the Base Figure.

Due to the limited size of NVTA and its operating budget, it is not feasible to conduct an independent disparity study at this time.

## **5. RACE-NEUTRAL MEASURES AND DBE CONTRACT GOALS**

US DOT regulations require that race-neutral methods be used to the maximum extent feasible to achieve the DBE overall goal. Race-neutral methods include

- a. Making efforts to assure that bidding and contract requirements facilitate participation by DBE firms and other small businesses;
- b. Unbundling large contracts to make them more accessible to small businesses;
- c. Encouraging prime contractors to subcontract portions of the work that they might otherwise perform themselves; and
- d. Providing technical assistance, communications, programs, and other support services to facilitate consideration of DBE and SBE (Small Business Enterprises) firms.

NVTA will continue using race-neutral means to encourage their transit service prime contractor to utilize DBE firms when possible. Implement semi-annual meetings with the contractors to discuss potential subcontracting opportunities.

## **6. PUBLIC PARTICIPATION**

NVTA has sought and encouraged public participation from minority, women's and general contract groups, through its participation as member of the BOC (Business Outreach Committee), a consortium of Bay Area Transit and Transportation agencies, that assists Disadvantaged Business Enterprises (DBEs) and other small firms with expansion of their business through training, technical assistance, and relationship-building with agency staff, and the contracting community of the San Francisco Bay Area.

Hosting and participating in public events very limited during the triennial reporting period during the period of the National Pandemic (COVID-19), however NVTA and their partners (BOC) were able to conduct several major events virtually. These free webinar events were to encourage and engage DBEs and small businesses in working with NVTA, to expand their business, and to further their knowledge in working with government agencies. Invitation letters and flyers are distributed to over 100 hundred organizations such as the African American, Black, Hispanic, Asian, Filipino, and American

Indian chambers of Commerce in the areas of Sacramento, San Francisco, San Jose, and Sonoma; the Builders Exchange in the counties of Alameda, Contra Costa, San Francisco, San Joaquin and Santa Clara; the US Small Business Administration; Veterans Business Outreach Center; National Organization of Minority Architects, San Francisco Chapter; Women in Consulting; Department of General Services Office of Small Business Certification and Resources; National Association of Women in Construction; American Subcontractors Association; Small Business Development Centers at various junior and state colleges; Minority Business Development Agency US Department of Commerce, etc. In addition, NVTa has made direct preliminary outreach efforts by phone and email to the Napa Chambers of Commerce, American Canyon Chambers of Commerce, prime and sub-contractors, posting events on its website and public information display case. Some of the major events hosted by the BOC and attended by NVTa were:

- *Meet the Primes.* Meeting was hosted virtually on October 21, 2021. These outreach events advised the public of upcoming projects from various transportation agencies, presentations, and allowed small and disadvantaged businesses to network with prime consultants.
- *Meet the Buyers Procurement Forum.* Meeting was held virtually on January 27, 2022. These events provided the opportunity for small, local, and disadvantaged business to introduce their products and services to participating Bay Area Transit and Transportation Agency's procurement staff and to receive information on upcoming contracting opportunities.
- *DBE Certification Workshop.* There were three (3) workshops conducted virtually on March 9 & 16, 2022 and on August 11, 2020. These events were hosted virtually and primarily in collaboration of BOC member agencies that are also a DBE certifying agency. The free workshops are open to all small business owners but also focused on encouraging Small Minority and Women-Owned business to become certified DBEs.
- *Public Participation Workshop.* This major event was held on April 11, 2022. This event allows the agencies to introduce their 3-year DBE goal to the public as part of the FTA guided public and businesses to question the agencies as to how their DBE goals were established. Due to a literal "shut down" of in-person public meetings at all partnering agencies' facilities this meeting was also conducted virtually.

All events were well received and attended by small businesses and DBEs.

NVTA anticipates limited Federal contracting opportunities for the next three (3) years and is determined further public outreach may not be beneficial to setting our Goal. During its outreach meeting and public notification period there were no comments or questions received by any firms or members of the public.

## **7. ONGOING OUTREACH**

NVTA will continue to improve and seek on-going public participation from community organizations through public meetings and planning documents comment periods on upcoming projects. For specific contracting opportunities, NVTA will continue to reach out to DBE firms directly in its market area by sending NVTA procurement opportunity announcements inviting them to bid. In addition, NVTA's website offers opportunities for the public to submit comments regarding services and program and to register for automatic notifications of procurement opportunities offered by NVTA.

## **8. PUBLICATION OF PROPOSED DBE GOAL**

Federal regulations require that notice of NVTA's overall DBE goal for FFY 2023 - FFY 2025 FTA-assisted contracts be posted on the NVTA's official website and also other sources (i.e. general circulation media, public information boards, etc.). Such notice must inform the public that the proposed DBE goal and its rationale are available for inspection during normal business hours for a period of thirty (30) days following the date of the notice. NVTA and the FTA as the agency's lead on behalf of the Department of Transportation (DOT) will accept comments on the proposed goal during that time period.

For the period beginning July 31, 2022, on October 9, 2022, NVTA published its notice of the 2.7% overall goal on its official website, local media and its public information bulletin board. No comment or request to review the goal rationale was received at NVTA during the 30-day comment period.

The goal of the Business Outreach Committee (BOC) is to assist small and disadvantaged companies in doing business with Bay Area Transit and Transportation Agencies.

## Doing Business with Bay Area Transit Agencies

The Business Outreach Committee (BOC) is a conglomeration of Bay Area transit and transportation agencies working together to assist Disadvantaged Business Enterprises (DBEs) and Small Business Enterprises (SBEs) through training, providing technical assistance, and relationship-building with agency staff and the contracting community of the San Francisco Bay Area.

DBE programs are required by the U.S. Department of Transportation (DOT), and as recipients of DOT funding, transportation agencies are required to:

- Adopt DBE programs and policies
- Establish overall and contract-specific DBE and SBE goals
- Encourage utilization of certified DBE firms and
- Act as a resource to DBEs and SBEs

Some agencies have also adopted SBE and/or Local Business Enterprise (LBE) Programs that apply to non-federally and federally-funded procurements and contracts.

### How the BOC Can Help

BOC members can:

- ❖ Explain DBE, SBE, and LBE program goals and needs
- ❖ Alert you about upcoming Invitations for Bids (IFB) and Requests for Proposals (RFP) at individual agencies
- ❖ Answer questions about specific bid opportunities
- ❖ Offer DBE certification classes for your area
- ❖ Provide contact information of prime contractors on specific jobs
- ❖ Add your firm to appropriate bidders' lists
- ❖ Help you locate support services
- ❖ Assist DBE, SBE and LBE firms with agency contracts

### What is a DBE?

A DBE is defined as:

- A for-profit small business concern
- At least 51 percent owned and controlled by one or more individuals who are both socially and economically disadvantaged. Such individuals could be Black Americans, Hispanic Americans, Native Americans, Asian-Pacific Americans, Subcontinent Asian Americans, Women, and any additional groups on a case-by-case basis
- Personal net worth does not exceed \$1.32 Million
- Annual average gross receipts over the previous three fiscal years does not exceed \$28,480,000 (\$56,420,000) for airport concessions in general, with some exceptions

### How to Get Certified as DBE Firm

Most of the BOC agencies participate in the California Unified Certification Program (CUCP), which offers "one-stop shopping" to interested firms. Firms only need to apply to one participating CUCP agency for certification in the state of California. Follow these guidelines to get certified:

- ❖ Go to the California Department of Transportation Office of Civil Rights at <https://dot.ca.gov/programs/civil-rights/dbe-certification-information> and check if your firm meets the eligibility criteria as stated in **49 Code of Federal Regulations Part 26**.
- ❖ Complete the online CUCP DBE Certification Application Package. Reach out to the certifying agency located closest to your primary business location for questions or assistance with the online application process.
- ❖ The CUCP certifying agency will determine whether a firm qualifies for DBE certification after a thorough review of the firm's application, documentation and information obtained from an on-site visit.
- ❖ A DBE certification issued by one CUCP member will be accepted by all other CUCP member agencies. **DBE certifying agencies in the Bay Area are BART, Caltrans, SFMTA, SamTrans, and VTA. A business owned and operated by socially and economically disadvantaged individual(s) does not have to be a certified DBE to bid on or be awarded contracts.**

## Productivity is Not a People Issue in Construction: It's a Process One

Construction has had a bad rep when it comes to productivity. Studies over the last several years have indicated that the industry suffered from low productivity. A 10-year analysis by McKinsey from 2005 to 2015 found that construction-labor productivity in the United States hasn't kept pace with other industries.

But this is no longer the case. Over the last few years, construction has made measurable improvements in its productivity thanks to the use of better technology and data.

According to the 2019 USG + U.S. Chamber of Commerce Commercial Construction Index (CCI), 78% of contractors believe that advanced technology can increase productivity. New building methods and practices have also proven to give construction professionals a boost. Doge and Analytics' report, Prefabrication and Modular Construction 2020, found that about 90% of firms report that "they achieve improved productivity, improved quality and increased schedule certainty"

when using prefabrication compared to traditional stick-built construction.

We're certainly seeing pockets of hope, though there's still a lot of work to be done. In particular, companies need to refocus their efforts on improving the productivity of their systems, rather than the people who work in their firms.

### Individual Vs. Organizational Productivity

As the statistician and management consultant W. Edwards Deming said in his book *Out of the Crisis*, "94% of most problems and possibilities for improvement belong to the system, not the individual."

While it's worthwhile to increase the efficiency of each individual employee, this isn't the most effective way to improve organizational productivity.

Why? Because in an industry like construction, employees rarely (if ever) work in isolation. People in our field are always working with teams, and they rely on systems and processes to get things done.

As such, increasing productivity in construction should be focused on strengthening the founda-

## Good News for Women in Construction: Employment Rising

The number of women employed in the construction industry grew substantially in 2019 rising to around 1.2 million, surpassing the peak of pre-recession employment level. As the construction skilled labor shortage remains a key challenge, adding new workers is an important goal of the industry. Bringing additional women into the construction labor force represents a potential opportunity for the future. Here we explore the state of women in the construction industry us-

ing labor force statistics from the Current Population Survey (CPS).

During the Great Recession, the number of female construction workers declined sharply by almost 30 percent to 807,000 by 2010. From 2010 to 2017, the total slowly expanded to around 970,000 but remained below the peak of pre-recession levels. The number of women working in construction increased to almost 1.2 million in 2019, up by 6% from 2018 after a 13% increase in 2017. This puts the 2019 total above the peak of pre-recession levels of 1.13 million.



Overall, the share of women in construction increased to 10.3% in 2019. According to the Current Population Survey, women in the construction are mostly involved in such occupations as office and administrative support, management, business and financial operations. Sales and office occupations employed the largest number of women within the construction industry. For example, women accounted for 74 percent of workers in sales and office occupations, including 446,000 women in office and administrative support, and 35,000 in sales and related occupations in 2019. More than 418,000 women were engaged in management, professional, and related occupations.

While construction and maintenance occupations account for the largest number of employees in construction, and is where additional workers are needed, women comprised only 3 percent of the such occupations. More improvement is needed here. Other groups such as production, transportation, and material moving occupations, and service occupations employed only around 9,000 female workers.

## 3 Steps to Add Risk Management Into Your Construction Bid Preparation

Effective risk management is key to every successful construction project. It can be the difference between making a nice profit and breaking even or worse, suffering a loss. So when should you begin your risk assessment? Are you doing it during contract negotiations or are you waiting until after you've received a notice to proceed? The truth is, risk management should begin during the bid preparation.

Putting together a winning bid package requires a lot of time and effort. It starts with reviewing and fully understanding the plans and specifications to accurately estimating costs for labor, materials, and equipment.

Making even the smallest mistake can mean the difference between having a winning bid

proposal and missing out on a coveted project. Incorporating risk analysis into your bidding process can result in more accurate pricing and can win you more work. It can also improve your bid/no-bid decision-making process.

### Identify the Risks

The first step is to identify all the potential risks that could arise on the construction project. This should not be a guessing game. Carefully review the bidding documents, plans, and specifications for the project. Once you have a full understanding of the scope of the project you can start identifying the issues that may arise down the line.

Rely on your previous experiences by reviewing similar projects you've completed in the past. Get the key players of your project team together to hash out the probable risk and potential opportunities. If you've never worked with a potential client, do your due diligence and conduct some research on them.

Common risks include incomplete construction documents, site conditions, accelerated timelines, safety concerns, delays, change orders, and unexpected increases in material costs.

### Prioritize the Risks

Once you've identified the potential risk, the next step is to prioritize those risks. To do this you need to identify what impact each risk will have and the probability that it will occur. High impact, high probability risks should go to the top of your list with risk with low impact and a low probability of occurrence at the bottom.

Take into account how much time, money, and work each risk will require to effectively manage. This is a good time to review your bid/no-bid decision. If you've identified a large number of high impact, high probability risks it might be time to walk away and move on to your next opportunity.

### Manage the Risks

Now that you've identified and prioritized the risks, it's time to determine how you will manage each risk. Decide if you can avoid, eliminate, reduce, transfer, or accept each risk. In regards to bid preparation, risk avoidance means deciding not to submit a bid.

Eliminating, reducing, and accepting risks takes careful planning. Break down each risk into actionable items. Determine what additional resources will be needed and be sure to incorporate those mitigation costs into your bid. Don't overcommit your resources to handling multiple risks. You may have to bring in additional labor or rent additional equipment to manage all your risks effectively.

Don't overlook transferring risks back to the owner or client. Be sure to communicate with the

## New Funding Rounds Announced for the California Small Business COVID-19 Relief Grant Program

California's Office of the Small Business Advocate (CalOSBA), part of the Governor's Office of Business and Economic Development (GO-Biz), announced today four new funding rounds for the California Small Business COVID-19 Relief Grant Program following Governor Gavin Newsom signing into law a comprehensive package of immediate actions that speeds much-needed relief to individuals, families, and businesses suffering the most significant economic hardship due to COVID-19.

Guided by a principle of equity, the Program provides a crucial financial lifeline to traditionally underserved small businesses and non-profits. In its first two funding rounds, the Program selected just over 40,000 small businesses and non-profits to receive approximately \$500 mil-

lion in grant funding. More than 350,000 small businesses and non-profits applied in a competitive process, with funding requests totaling more than \$4.5 billion. Additional preliminary data can be found here.

The recently signed package provides \$2.075 billion – a four-fold increase to that initial \$500 million – for grants up to \$25,000 for small businesses impacted by the pandemic. The new package also includes a \$50 million allocation for non-profit cultural institutions. Four competitive funding rounds will be conducted by CalOSBA's selected intermediary, Lendistry. **Round 3 (waitlisted applicants from Rounds 1 and 2): Friday, March 5th through Thursday, March 11th, 2021**

- Eligible applicants: This is a closed round and only available to eligible applicants who were waitlisted in Rounds 1 and 2 – only existing applicants will be selected. If you were waitlisted, you do not need to reapply. New applications will not be accepted in this round.
- Eligible grant award: \$5,000 to \$25,000
- Details: This is a closed funding round; no new applications will be accepted

**Round 4 (non-profit cultural institutions only): Tuesday, March 16th through Tuesday, March 23rd, 2021**

- Eligible applicants: Only non-profit cultural institutions with any revenue size that meet eligibility criteria found at CARE-reliefGrant.com
- Eligible grant award: \$5,000 - \$25,000
- Details: Eligible non-profit cultural institutions must complete a new application even if they already applied in Rounds 1 and 2

### 5 Best Small-Business Loans for Veterans

Small-business loan options for veterans include loans for working capital, expansion and unpaid customer invoices.

Veterans who are entrepreneurs — like all entrepreneurs — may need funding at various stages of running a small business. The Small Business Administration previously offered a Veterans Advantage loan to help with these costs, but that program has been discontinued.

That means if you're a veteran or active-duty servicemember, the best small-business loan will be the one that offers the most favorable terms to meet your needs — whether that's hiring new employees, purchasing equipment or covering other costs.

#### Can you get a VA business loan?

The Department of Veterans Affairs does not provide business loans. But a different government agency — the Small Business Adminis-

tration — previously offered discounted loans to veterans via the Veterans Advantage lending program, also known as "VA loans."

VA loans reduced or eliminated fees on SBA 7(a) loans for veteran-owned businesses. This program is no longer available, but veterans can still apply for other SBA loans.

SBA loans are available through banks, credit unions and other lenders. The government partially guarantees SBA loans, so lenders may offer you a lower interest rate or more flexible terms. However, strict underwriting criteria and a long application process may make other options — like an online lender — better fit your needs.

#### Other SBA programs for veterans or servicemembers include:

- **Military Reservist Economic Injury Disaster Loan Program.** The MREIDL

can provide up to \$2 million if you have an essential employee who is a military reservist and gets called to active duty. This program is for covering regular business operating costs, not starting or expanding a business.

- **SBA 8(a) program.** The SBA offers this business development program to eligible businesses, which can include those owned by veterans. The SBA 8(a) program provides small businesses with a certification that can improve their chances of winning government contracts, as well as help navigating the bidding process.
- **Patriot Express Pilot Program.** This program offered low-interest Patriot Express Loans to veterans and other members of the military community. Patriot Express Loans were discontinued in 2013.

#### Are there startup business loans for veterans?

Lenders generally prefer to do business with established companies that have strong cash flow. This often disqualifies startups with less than a year of operating history and little revenue.


However, veterans and other new business owners aren't completely out of luck: If you have good personal credit, your options include business credit cards and personal business loans.

- **Business credit cards.** These typically provide up to \$50,000 in revolving credit, meaning you can borrow and repay from the credit card as needed, and pay interest only on withdrawn funds.

owner or owner's representative when preparing your bid to get clarification on what risks they will assume and which ones you will be responsible for managing. Work with your insurance provider to determine which risks are covered under your current policies along with other options for protecting your company against risks.

### Final Thoughts on Construction Risk Management

Identifying and managing risks are probably the most overlooked aspect of preparing a bid

proposal. By starting the process early you can avoid bidding on projects that won't make you any money.

It will also lead to more accurate bids with reasonable contingencies built in and result in your company winning more bids. Project management will run smoother and you'll save time, money, and resources as work progresses.

tion — i.e., the systems and processes — that power teams in your organization. Doing so will yield results that are far more superior than simply improving individual efficiency.

## 3 Tips to Help You Choose the Right Construction Association

Have you considered joining a construction association but haven't gotten around to it yet? Or maybe you are a member of an association that isn't quite meeting your needs. Regardless, a little research is all you need to identify the right construction association—one that can benefit both you and your business. Here are three tips to guide you down that path.

**1. Create an action plan.** Figure out what you want from an association, and find the one that offers it. That sounds like a simple step, but it is one that is often overlooked. Don't be distracted by a lengthy list of services and programs. Make a list of what is important to you and stick to it. Some things you may want to consider are training, education, business development tools, apprenticeship training, legal resources, networking, and discounted products and services. Figure out what you need, and disregard the rest. You wouldn't pay for a large wheel loader when all you need is a skid-steer.

**2. Perform a background check.** Determine if the association has a strong and reputable presence. The membership listing is a good place to start. If a national presence is important to you, then definitely consider that, but usually the state and local memberships are a better in-

duction of what an association can offer you. Next, dig deeper and understand how active the organization is. Are the meetings well attended? Are there numerous opportunities for training? Make sure the associations you are considering are strong and active in areas that interest you. To get a good handle on this, I would suggest talking to existing members and consider joining them at a meeting or event. It goes without saying that reputation is important. Will your relationship with this organization help to solidify your reputation as a leader in your field?

**3. Check to make sure it meets your needs.** Ensure the association aligns with your business and personal identity. For example, associations tend to be either union friendly or merit-shop and often endorse one political party over the other. Make sure you understand what they stand for—you don't want your association fees fighting against you. Also, consider whether a trade-specific association is more suitable for your business than a general one. They may be smaller, but often have better industry-specific training and resources.

If you are fortunate enough to still be considering several options after your research, my advice is to pick the association with meeting times that don't conflict with your wife's book club night.

## 5 tips to get subcontractors to fill out prequalification forms

Getting subcontractors to fill out qualification forms can be a tricky task. Despite their best efforts, general contractors may struggle to get responses, or they receive them with incomplete or inadequate data to complete the assessment. With defaults on the rise, it's important that you get accurate data so you can make informed decisions and mitigate risk.

Picking the right subcontractor is crucial to keeping a project on track and on budget, but what if your prequalification form is creating a bottleneck? Long, overly complicated forms and questions that don't relate to the project can cause subcontractors to get stuck, decrease your response rate, and delay bids.

To help, here are five subcontractor management best practices that general contractors can implement to get subcontractors to fill out prequalification forms in a timely, accurate manner.

### Invest in your relationships

It's said all the time, but it needs to be reiterated: construction is a relationship-based industry. Building strong relationships takes effort from subcontractors, general contractors, and even owners. Prequalifying subcontractors can feel transactional, especially when you're asking for sensitive financial information. Having empathy for your subcontractors and the amount of prequalification requests they get is an important start. That's why prequalification technology is a must for choosing subcontractors today. A stronger relationship with a subcontractor means they're more likely to submit a response.

The construction industry is adopting and implementing more and more technology, but building strong relationships still requires communication and a personal touch. Set up face-to-face meetings to descope projects with subcontractors and give them feedback throughout the prequalification process. It increases transparency and fosters long-term relationships because it starts with mutual respect and understanding.

### Automate your prequalification process

Managing subcontractors and the prequalification process takes time. There are dozens of tasks involved. You have to reach out to subcontractors, educate them on the process, and get them to provide all the data you need. Traditional prequalification processes are repetitive and involve collecting and entering the same information over and over again. Any time you have repetitive processes, there is an opportunity for automation to increase efficiency and streamline operations.

There are email automation tools such as Zapier and Boomerang that can help, but it's still not enough. Subcontractor prequalification

software takes it one step further by sending automated follow-ups, reminders, and renewals to collect up-to-date info — saving general contractors hours. Once you've gathered accurate information, you can receive automated risk mitigation recommendations to identify and reduce risk early in the preconstruction process.

### Trim down your questionnaire

Prequalification forms should be easy and straightforward for subcontractors to fill out. If a subcontractor's response doesn't change whether you would work with them, it's probably not worth asking. You want as few barriers as possible between you and your subcontractors, and part of that friction lives within the prequalification form. Using the same form for every project creates unnecessary work and complicates the process. Every project is different, so your prequalification forms should be, too.

Trim down your questionnaire and have multiple variations for different types of subcontractors and projects. Improve it even more by getting feedback from subcontractors. This will also help you evaluate if they're a fit for that project, which can create a successful prequalification workflow. If there is a question on the form that's holding up the prequalification process, take the time to listen and work on optimizing your forms for future subcontractors. An easier form equals more responses.

### Leverage your project teams

The entire organization needs to have a risk mindset when it comes to managing subcontractors. Since project teams are on the front lines talking to subcontractors, they need to be well informed of the prequalification process and should advocate for the risk team by encouraging subcontractors to participate. Communicating the prequalification process to your project teams enables them to answer questions as they arise and fully understand the workflow of your subcontractors.

If you use a homegrown system, which is inherently unique to you, the subcontractor has to learn a new prequalification process and find their own way. They have to get used to your form, login process, and submission steps. With subcontractor prequalification software, the process is the same with all the general contractors. Subcontractors can greatly reduce the time it takes to fill out a form by being able to save safety documents, financial records, and even canned responses to frequently asked questions.

# Recipient Role

## DBE Regulations: 49 C.F.R. Part 26 (Airport Concessions, Part 23)

State and Local Transportation Agencies (Recipients/Grantees) receive funds from operating administrations directly or as a subrecipient.



# Goal Setting Process

## 49 C.F.R. Part 26 §26.45

- Gather the data – projects to be expended with FTA funds (Transit Vehicle Purchases (TVMs) not included)
- Review external evidence
- Consult with outside stakeholders -
- Complete DBE Goal Methodology – a document
- Notify the public – advertise proposed goal on website and/or publications
- Submit Goal Methodology to FTA on August 1 for approval – every 3 years

# Triennial Goal Methodology

- Step Two – Evidence/adjustments consideration
- Consultative Process – describe the stakeholder meeting, including comments received
- Race Conscious (RC)/Race Neutral (RN) Split – RC assists DBEs ONLY. RN assists all small businesses, including DBEs
- Proof of public notice

# Step One – Base Figure

Prescribed Formula

Base Figure represents the relative availability of DBEs in relevant Geographic Market Area (GMA)  [\(§26.45\(c\)\)](#)

$$\frac{\text{\# of ready, willing, and able DBEs}}{\text{\# of all firms ready, willing, and able (including DBEs and non-DBEs)}} = \text{Step One Base Figure \%}$$

# Step One – Base Figure Cont.

## Weighting by Work Category

- Ensures that Step One Base Figure is as accurate as possible
- Provides a more narrowly-tailored model of availability
- Weights used are allocation of dollars spent within each work category
- Resulting percentage shows where dollars are allocated to each work category (prime and subcontracting work)
- Work category may be NAICS, internal work codes, etc.

## Step Two – External Evidence/Adjustments

Examine all available evidence and determine what adjustments, if any, are necessary. **Adjustments are not mandatory.**

- Capacity of DBEs to perform work
- Statistical disparity studies
- Barriers to DBEs to form, grow and compete (financing, bonding, & insurance)
- Past participation
- Input from interested parties
