#### 9.1 Agricultural Workers Vanpool Program (AWVP) Report

Staff provided an update on the AWVP efforts to date.

#### 9.2 Yountville Park and Ride Lot

Board members Saucerman and Chilton excused themselves from the meeting during the discussion of this item.

Staff reviewed the desired parcel in Yountville for the proposed park and ride lot. When completed this parcel, bounded by Solano Avenue to the west and Wine Train right of way to the east, and California Drive to the north, will accommodate estimated 8 to 10 parking spaces which NCTPA will promote for VINE Route 29 rider usage. Further, the park and ride lot will be open to the public and overnight parking is prohibited.

**MSC\* BENNETT / GARCIA to APPPROVE** (1) negotiating the purchase of property from the Town of Yountville for the purpose of building a Park and Ride lot and (2) the temporary use as a Park and Ride lot for the Route 29 service.

## 9.3 Recommendation from the Technical Advisory Committee (TAC) on how to Divide the Costs for Sustainable Napa County's Work on the Sustainable Communities Planning Grant Application

At the July 21<sup>st</sup> Board meeting the Board asked staff to develop several formulas for distributing to the jurisdictions the \$10,000 cost of Sustainable Napa County's work on the Sustainable Communities Planning Grant application. The NCTPA Technical Advisory Committee (TAC) voted to distribute this cost using the following Blended Rate Method:

**MSC\* GARCIA / GINGLES** to **APPROVE** TAC's recommendation of using the "Blended Rate Method" (above) to divide the cost amongst the jurisdictions for paying Sustainable Napa County for their work on the Sustainable Communities Planning Grant application.

#### 9.4 Legal Services Procurement

Subsequent to the Board action in June to authorize release of the RFP, the NCTPA staff and Napa County staff undertook a new round of discussions as to the feasibility of continuing to use the County Counsel's office for NCTPA legal services. Those discussions lead to a potential agreement subject to NCTPA Board and County Board of Supervisors approval. The agreement calls for a .5 FTE Deputy County Counsel assigned to the NCTPA over a 3-year period. The annual cost for such services would be approximately \$120,000 annually as a fully load cost allocation to NCTPA.

Board members Techel, Chilton, and Bennett voiced concerns with cancelling the RFP and competitive bid process. Further concerns were raised whether a county employee would be able to devote the necessary time needed to NCTPA business and be objective and supportive of NCTPA if conflicts between county and NCTPA occur.

MS GINGLES / DUNSFORD to APPROVE with TECHEL, CHILTON, AND BENNET OPPOSING to (1) Terminate the Request For Proposal (RFP) No. 10-03 for legal services, (2) Approve a contract with Napa

County for legal services in an amount not to exceed \$120,000 annually, and (3) Authorize the Executive Director to sign the proposed contract with Napa County for legal services.

## 9.5 Adoption of NCTPA Policies, Practices, and Procedures Manual Section 2: Accounting, Audit and Financial Management Policies

Recent audits have recommended that the agency develop and adopt its own formal set of policies and procedures that are specific too and ensure compliance with all federal, state, and local requirements. Board action approved Section 2; Accounting, Audit and Financial Management Policies of the NCTPA Policies, Practices, and Procedures Manual.
