#### 3. Chairperson / Committee Members / Staff Update

Vice Chair Weir recently checked out the new 35 foot buses at Earth Day and found them to be a little tight getting in and out of due to the chair configuration. Chair Wall pointed out that having a wheelchair on the buses causes a lot of seats to be lost.

Committee member Deale asked if the air conditioning would be working on the buses as it is becoming warmer. Cheryl Drake of Veolia stated that a repair tech would be on site tomorrow (May 3<sup>rd</sup>) to repair the units that are not functioning properly.

Committee member Blackstock wanted it to be known that the stop near his home (Jefferson & Calistoga) was being misused by homeless individuals and wondered if there was any way to stop the misuse. It was suggested by NCTPA staff member Tom Roberts that extra attention be given to the stop by NCTPA's cleaning crew.

# 7. Review of the FY 2013-14 Transit Budget (Information)

NCTPA staff member Tony Onorato presented the committee with the draft FY 2013-14 budget. Committee member Schmeder pointed out to NCTPA staff member Onorato that one of his formulas was incorrect and that it was possible that all his formulas are incorrect. Committee member Schmeder was also curious why there was such a dramatic fluctuation in State Transit Assistance (STA) funds. NCTPA staff member Onorato explained that this fluctuation was caused by several factors, the leading one being legislative changes. The funds are allocated to NCTPA by the Metropolitan Transportation Commission (MTC).

#### 8. Short Range Transit Plan (SRTP) (Information)

NCTPA staff member Tom Roberts presented the committee with the SRTP created by CDM Smith. He asked the committee to provide any changes to him via email within 48 hours. Chair Wall asked that Wi-Fi on all the buses be added as a project.

#### 9. Transit Manager's Update (Information)

NCTPA staff member Tom Roberts reviewed some of the up and coming projects/events that would be affecting the VINE. He spoke to the committee about the new fareboxes arriving in June and the different marketing campaigns that will be used to boost the exposure of the VINE. Final NCTPA staff member Roberts spoke on the delays that will most likely take place during the Bottle Rock music festival.
