Measure T Timeline



Measure A

½-cent local sales tax approved in 1998 to fund the Napa River Flood Protection Project

Measure T

Goes into effect July 1, 2018. Provides funding for the maintenance, rehabilitation, and reconstruction of local streets and roads, encompassing all Complete Streets elements.

Measure U

Goes into effect July 1, 2025. Extends the Measure until 2055. Measure T is sunset in the process.

Measure T

Voter-approved to continue existing ½-cent sales tax, with revenues now dedicated to local transportation and street infrastructure beginning in 2018 after the expiration of Measure A

Measure U

Voters approved Measure U to replace Measure T. This continues the local ½-cent transportation sales tax, while allowing the ability to bond revenues, fund larger capital highway projects, expand the 7% equivalent Fund requirements

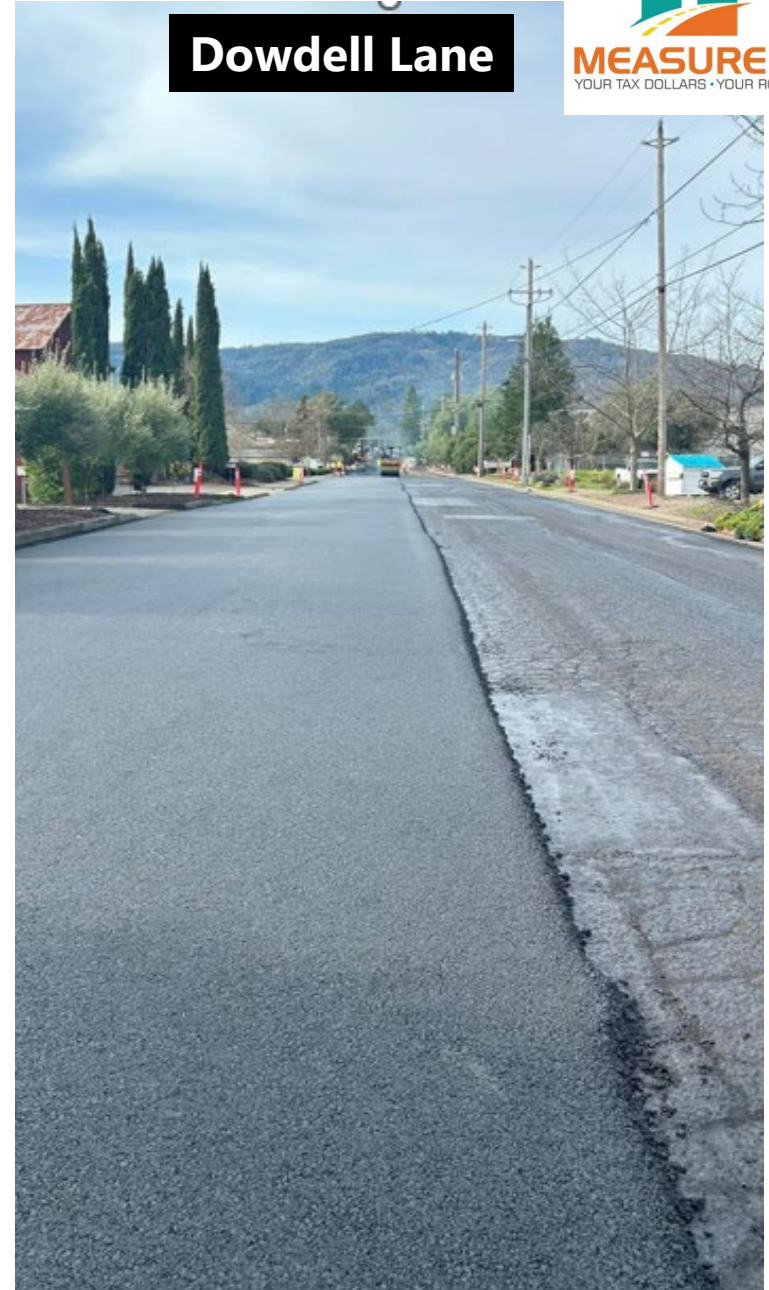
